#### Day 1 - Session 1

Ms. Subhashree Krishnan, India Head – Pricing & Procurement, KSR Freight forwarders Pvt. Ltd. delivered her talk on "Role of Logistics in Online Business". She started the session by sharing her life story and then she moved to the topic by explaining, "What is Logistics?" with examples. She also explained in detail the role of logistics in e-commerce and the process of business from ship orders to customers. She expounded that "Buy Now" is the triggering factor for online business success. She explained the role of logistics management in Procurement, Inventory management, Warehousing, Order Management, Packaging, Labelling, Billing, Shipping, Payment Collection, and Return or Exchange. She further shared that logistics translates to increased efficiencies, lower costs, higher production rates, better inventory control, smarter use of warehouse space, increased customer and supplier satisfaction, and an improved customer experience. Overall, this session was highly interactive and engaging. During this session, many questions were put forth by the students, which were also answered by the resource person.

Parimalam felicitated the Resource Person, Dr. K.S. Kamaludeen with a shawl and memento. The Convener, Dr. Justin Rayappa felicitated the Head of the Department of Economics with a memento.

Dr. K.S. Kamaludeen, the Director of Bluebharath Exim Pvt. Ltd, is an International Trade Entrepreneur, and also an Educationalist, IT Professional, Internal Audit, Writer and Mentor. He graduated in Mathematical Science and currently he is a member of Governing Council in Chendu College of Engineering & Technology in Madurantaham. He is also a Visiting Faculty in Aalim Muhammed Salegh College of Engineering, Chennai and Advisory Member in SYPA TREE, Chennai. He has also 24 years of experience in International Trade Business to Singapore, Dubai and Malaysia.

He delivered his talk on "International Trade Management" using PPT. He explained in detail about the software "B-Accuracy 7 in 1 ERP software" for business management system and academic purpose. He covered trading policies, exchange of capital, producing and sourcing goods and services from across the globe. He also explained that how the extensive and comprehensive courseware meets the demands of the ever-changing global standard. He also enlightened about the world trade, exchange of capital, trade promotion, policies and strategies at the regional, national and global level. After that, he expounded about the fundamentals of risk management for foreign policies, emerging global businesses, foreign exchange and the impact on the political and legal environment. He explained in detail about the concepts for cross-border trading and taxes and factors affecting the global businesses.

The third session was conducted on google meet. Mr. Vijay Pravin Maharajan, Founder and CEO of BitsCrunch, from Germany was the resource person. He has a Masters in Electrical Engineering and Information Technology of Technische University in Germany. He has more than 8 years of technical experience in blockchain, mobility, automotive and telecom industries. His specialised domains are Entrepreneurship, Public Speaking, Blockchain, NFT, Data analytics, Data Science, Machine Learning and Artificial Intelligence. He is the first Indian to be invited for a TEDx talk in Germany. He was awarded as "Top 40 Data Scientists in India" at the age of 40. He delivered his talk on "BLOCK CHAIN AND NFT". He also shared about "Bitcoin", the new emerging and evolving in paperless banking system. Then he explained about the operations across a network of computers using blockchain technology. Finally, he explained about how, many businesses across the world have successfully integrated block chain technology. He also explained about the NFT which has been growing in popularity since 2021 and it is bound to grow even more in the future.

Day 2

The Second day programme started with a formal prayer. The Resource Person, Mr. Jebastin (Founder - Grow Wider International Pvt. Ltd.) delivered his talk on "Basics & Business Opportunities in E-commerce." The Convener, Dr. J. Justin Rayappa felicitated the Resource Person, Mr. Jebastin with a shawl and memento. Mr. Jebastin, the Resource Person explained the process of storing, packing, and delivering in Amazon. He said that we can use only one fulfillment option for each product and different fulfillment options for different products. Most sellers use a mix of multiple fulfillment options, depending on their product range and category. If we join FBA, we can send our products to the Amazon Fulfillment Center and Amazon takes care of the rest. Once an order is received, we will pack and deliver our products to the buyer as well as manage our customer queries. He also told us about the Prime Badge for every FBA product, which increases chances of winning the Offer Display. Once our products have the Prime Badge, products are more competitive and gain access to crores of our loyal Prime Customers. It increases visibility when customers are searching for the products they want to buy. Prime products get upto 3X increase in sales compared to the non-Prime products. Once an order is placed, Amazon handles everything from packaging to shipping your product to the customer. Amazon ensures free & fast delivery for all Prime customers to India's serviceable pin codes. He explained that Amazon Easy Ship is an end-toend delivery service for Amazon. The packaged product is picked up by Amazon from the seller's location by an Amazon Logistics Delivery Associate and delivered to the buyers' location. Finally he also patiently answered the questions put forth by the students.


#### Key Takeaways
