## STRUCTURE OF THE COMPETITION BRACKET 16 METHODOLOGY

Round 1 :

\*Four-minute speech contest. At the end of this, sixteen participants will progress to the next round.

Round 2 :

\*Four-minute speech by Participant A drawing upon perspectives from both the U.S. and Indian Constitutions.

\*Four-minute speech by Participant B drawing upon perspectives from both the U.S. and Indian Constitutions.

At the end of this, eight participants will qualify for the next round.

Round 3 :

\*Four-minute speech by Participant A

\*One-minute rebuttal by Participant B

\*Four-minute speech by Participant B

\*One-minute rebuttal by Participant A

\*Question(s) from the judges (one minute per participant)

At the end of the third round, four participants will proceed to the finals that will be held in Chennai.
